ADMINISTRATIVE ITEMS

- Membership health concerns
 - o None
- Approve December 2020 meeting Minutes
 - Tom Bachey motioned to approve Minutes. Jeff McElravy seconded the motion and the motion was approved
- Treasurer's Report (Bob G.)
 - Net income for 2020 was \$4376.41. We have had positive profits in 4 of the last 11 years. Over that span we have had a net income of \$3460.
 - o Current Bank Balances: checking \$4,798.78; savings \$31,543.87
 - o \$4,170.56 in 2021 BUFF membership renewals received to date
 - Steve Alexander and Tom Bachey are volunteers for the financial audit.
 - Harry Pass proposed accepting Treasurer's report. Jim Hunt seconded the motion and the proposal was approved.

New BUSINESS

- Minor budget adjustment (Bob G)
 - Bob Gustafson recommended adjustment in the budget adopted in Dec 2020. The main goal is more specificity for the website and emailing services. The proposed revisions were:
 - Acct 6220 Website Expense (hosting, domain, security) increase from \$200 to \$250
 - Acct 6221 GoDaddy Email (BUFF internal mail: info, Treasurer & librarian) no \$ change
 - Acct 6222 MailJet eMail Service no \$ change
 - Acct 6231 Emailing Service retired
 - Net effect raises Budgeted expenses from \$12,914 to \$12,964

- Bob's proposal was seconded by Jack Gormley. The motion carried with 15 approves and 1 disapproved.
