Administrative Items:

 - o Jerry Schatzman will be having back surgery soon
- Previous month's BOD meeting minutes approval
 - Bob Gustafson motioned to accept the April 2019 Minutes. The motion was seconded by Jeff McElravy and approved by the BOD.
- Treasurer's Report (Bob G.)
 - The April financial report was emailed to BOD prior to the meeting
 - The budget was adjusted to reflect authorized changes: line item 6820, Treasurer's expense, was raised by \$220 and line item 6340, Contributions, was raised by \$650.
 - Accounting for Banquet meals was converted to 'flow-thru' basis
 - o 2019 Philanthropic grants and gift checks were mailed in April
 - o 2018 tax filing submitted to IRS
 - o Charitable Registration for 2018 submitted to State of Ohio
 - o VOA meeting room is now reserved for July 2020 general meeting
 - o Pine Lake Trout Club membership renewed for 12 months
 - o Buff brochures are in storage lockers
 - Jeff McElravy motioned to accept the Treasurer's report. The motion was seconded by Jim Boude and approved by the BOD.

New Business

- Decision on TU Madmen request for additional support for ODNR-DOW purchase of land for Mad River access (Bob G.)
 - o Bob motioned to donate \$500 to TU contingent on closing of the Mad River property
 - The BOD discussed the appropriateness of the action. BUFF does not provide financial support for government agencies. However, this proposal is a donation to TU, a non-profit and nongovernment organization, and funds are earmarked for river access property that will directly benefit of our members. This is in-line with prior donations (i.e. donation to TU for Four Mile Creek river access property that was purchased by Three Valley Conservation Trust).
 - o The motion was seconded by Jeff McElravy and approved by the BOD (no disapproval)
- Purchase of new projector (Bob G., Don K)
 - Bob Gustafson moved to authorize Don Kail and Ken Foltz to buy a club projector plus appropriate projector accessories for a total that is not to exceed \$500.
