Administrative Items/Proposals

The meeting was called to order by President Ken Dixon at 6:34 pm at the Springdale Community Center.

- Membership Health Concerns None reported.
- October BOD meeting minutes will review and approve in December
- Treasurer October 2014 Financial Report Bob Gustafson
 The financial reports through October were sent out in advance. Total Income through 10/14 is \$36,564 and Total Expenses are \$29,820. The Club has Total Current Assets of \$38,293.

 Ed Jones made a motion, seconded by Tom Smith to accept the October financial report. The motion was approved.
 - o Bob discussed BUFF dinner reservations declining over the last three years.
 - VOA 2015 Update The new rental contract for 2015 has been signed, at the same rate as 2014. Table water service for our meals is provided by Metro Parks not the catering service. Ed Jones made a motion, seconded by Bob Miller to pay VOA \$15.75 plus tax per month for coffee and water service. The motion passed.

 - o Three open Positions Secretary, Assets Management, Membership
- D. Bentley provided a proposed administrative update to GP05, Life Membership
 Awards, to reflect the calculations for maximum number of Life Memberships, as
 approved and used by the Board in October 2013. The Policy revision adds the following
 paragraph:
 - A ratio of 30/1, total BUFF Membership to Life Memberships is set as a maximum limit for consideration of awarding future additional Life Memberships.
 The total BUFF Membership number is defined as the sum of recorded Single Memberships + 2X the number of recorded Family Memberships, as of October 1st of that calendar year.

Tom Agin made a motion, seconded by Jeff McElravy, to approve the GP05 modification as proposed. The motion passed.

- Ken Dixon discussed the formation of the 2014 annual awards committee, made up of Duane Bentley (Chairman), Sue Jones, JR Jackson, and Lee Chambers. Duane discussed awards process planning and solicited nominations from the Board for the BOD Award.
- Committee report re the "Lou Haines Humanitarian Award" The committee discussed several factors, and recommended not pursuing this proposal at this time. Following further discussion, the recommendation was accepted as the position of the Board.
- A Volunteer Appreciation Award proposal was discussed. Sue Jones will head the committee, and return to the Board in February 2015.
- Reminder for December Meeting date changes The BOD meeting will be on December 10th and the Membership Meeting will be on December 17th. A mass e-mail and BUFFER reminder will be sent on the Membership Meeting change.
