Parky's Farm News:

We have just received a communication from the Hamilton County Park Board regarding the pond at Parky's Farm where so many of us have helped kids learn to love fishing. Briefly, although the long term fate of the pond is unclear (everything from relocation to turning into a wetland are being considered), the short-term prognosis is more favorable. The Park Board will organize a group of volunteers to clean the weeds out of the pond using rakes. Given this positive action we (Roger, Ken, Donn) feel that we should continue BUFF's efforts at Parky's Farm, as long as the weed conditions permit. Ken West is this year's leader. We plan to start on Friday April 13 and continue through the end of May, and then again in the fall, Sept/Oct (weed conditions permitting). As before, we will provide the necessary equipment and bait. Please come and help the kids fish from 10 a.m. to 2 p.m. each Friday. We are expecting to see the "old faithful" crowd, and hoping for some new faces. If you have not been active, this is an excellent event to get started. You can spend as little or as much time as you want and the rewards are excellent, not only in fish, but also in sharing the excitement of someone who has caught his/her first trophy. You are also welcome to fish for some of these monster bass and bluegills if you want to come early or stay after the kids fish. If you don't want to fish all you need do is show up at 10. Report from the Road – A Perfect Combination in North Carolina **Steve Bailey, Trips Coordinator**

I had the occasion to travel to North Carolina last week on some business. Enroute to my conference, I stopped off, March 11 and 12, in the Asheville area with my wife, Sharon at the Sourwood Inn. We came across the inn while searching for a fishing guide service in the area on the Internet. I found a website for Curtis Wright Outfitters and their site had link to the inn. On the inn web site I discovered a package deal of a night's stay at the inn and half day of guided fishing, at a nice discount for both. The package comes about because Jeff Curtis is the owner and operator of Curtis-Wright, and his wife Susan, is the Innkeeper at Sourwood. The Inn was great place to stay and the food served at breakfast time was remarkable. Due to their rather remote location, they offer a dinner on Thursday through Sunday. There is a lot more information about the dining arrangements on the web site.

We were pleasantly surprised at the quality of the inn and its remote serenity, yet it was only 20 minutes from Asheville.

Erich Sondraegger, a native of the area, led the half-day of fishing. Erich drove us to the Laurel River, about 20 minutes north of Weaverville, the home of Curtis Wright Outfitters. It was a grand day for fishing with high clouds, and temperatures in the mid forties as we started fishing. The Laurel River is clear freestone, delayed harvest stream. The gradient is very gentle, and the stream is wide enough for some easy casts. I waded in and got right to it. In fifteen minutes I had hooked up four nice rainbow trout and managed to land two, both of which were over twelve inches. This was going to be a good day! Erich worked with Sharon and helped her with her technique so much that she landed three or four nice rainbows that were also in the foot plus category. In the three hours that we fished she managed to also hook up another eight or ten nice fish. We were fishing a two-nymph system with a black bead head A.P. nymph on bottom and yellow sally above. A check of the stream entomology by Erich showed that we were definitely matching the hatch. I managed to land another six rainbows and one brown trout. Not one was less than twelve inches long and the last one was well over fifteen inches. By the time we stopped fishing at 2 p.m. it was about 60 degrees and the clouds had nearly cleared away. It was hard to call it a day when fishing was so good.

I plan a return trip there and I can definitely recommend both the lodge and Erich the guide to anyone interested. FFF Conservation Activities

The Federation of Fly Fishers (FFF) is the national organization that represents our fly fishing interests. B.U.F.F. is a member club of FFF. One of the key roles of FFF is to provide leadership in conservation activities that transcend specific fish species and environs.

A small committee led by Leah Elwell (FFF Conservation Coordinator) is actively networking with other conservation organizations and leading conservation efforts across the U.S. Listed below are some of the recent activities that the FFF Conservation Committee has pursued.

Positions/Letters/Press Releases

- Submitted letter apposing riders on legislation from Senator Craig (ID) that would weaken protection for salmon recovery in the Pacific Northwest (11/06).
- Submitted letter urging Senator Thomas (WY) to designate the Snake River as Wild and Scenic (11/06).
- Submitted letter to PacifiCorp regarding Klamath River dam re-licensing with several fishing organizations (11/06).
- Submitted letters regarding energy extraction and protection of specific areas from extraction in the West to Senator Burns (MT) and Secretary Kempthorn with Theodore Roosevelt Conservation Partnership (11/06).
- Submitted comments on BLM Bristol Bay Draft EIS Plan (12/06). The BLM Anchorage Field Office has prepared a draft Bay Resource Management Plan and Environmental Impact Statement. This plan will provide a comprehensive framework for managing and allocating uses of the BLM-administered public lands and resources within the Bristol Bay and Goodnews Bay areas of southwest Alaska. The plan will also provide direction for site-specific activity planning in the future. FFF position: we do not support any mining in this area. - Submitted letter to Montana Senate supporting 250' setbacks for development projects in Montana river riparian areas (12/06). The Montana Stream Legacy Act requires all new homes and commercial buildings to be set back at least 250 feet from the mean high water mark.
- Submitted letter to Senator Crapo supporting the re-introduction of the Tax Incentive Bill regarding Endangered Species with over 15 hunting, fishing and wildlife organizations (via Fish Net) (1/07). A bipartisan effort to further use of conservation incentives is underway in the U.S. Senate, where on December 6 Senator Mike Crapo (R-ID) introduced The Endangered Species Recovery Act of 2006 (S. 4087) with Senators Blanche Lincoln (D-AK), Max Baucus (D-MT) and Charles Grassley (R-IA) as cosponsors. The bill would offer \$400 million a year in tax credits, along with other tax deductions and exclusions, to landowners who take voluntary steps to help endangered or threatened plants or animals on their property.
- Submitted letter to Montana Senate supporting bridge access to rivers (1/07). The Bill will support the public's right to access Montana's rivers and streams from bridges throughout the state. The Montana Bridge Access Bill is sensitive to the needs of landowners, as well as river enthusiasts. It allows landowners to construct fences adjacent to bridges but requires fences to not block public river access.

Lawsuits

Below is a very brief summary of the suits that FFF has been involved in the last year.

- **Columbia River BiOP.** In 2005, the judge on this case rejected the Biological Opinion (BiOP) and gave NOAA 1 year to re-write it. An extension was allowed on the BiOP and the deadline is July 31, 2007. **STATUS:** Waiting for the new BiOP to be released.
- **NOAA Hatchery Policy.** In 2005, we joined a suit that contested the NOAA policy of grouping hatchery and wild fish populations together for recovery rules. **STATUS:** The arguments of this case are in development and will likely come before the court early 2007.

• **NOAA Downlisting of Upper Columbia Steelhead.** In spring 2006, FFF joined a suit in opposition to the downlisting of the Upper Columbia Steelhead. This case is essentially a microcosm of the NOAA Hatchery Policy case. **STATUS:** This case has been consolidated with the NOAA Hatchery Policy case and will be heard by the same judge.

Emerging Issues

- Rivers Coalition Lawsuit - Stuart, Florida. Residents are suing the Army Corp of Engineers for discharges of pollutants and excess freshwater into the St. Lucie River estuary which are destroying the estuarine environment and riparian rights of the homeowners. FFF is following this issue.
- Big Horn River Flow Issue - The U.S. Bureau of Reclamation, which controls flows on the Bighorn River (MT & WY), plans to set flows at 1,500 cubic feet per second. Fisheries biologists say that flow level would be devastating to fish numbers. To maintain a healthy fishery, flows should not go below a minimum flow of 2,500 cfs. We are following this issue and the Magic City Fly Fishers FFF/TU club in Billings, MT has been very active in this issue.

Conservation Committee Activities

- January 18 – Committee Conference Call was held
- One Conservation Grant request was discussed. Unanimous support for a monofilament recycling interpretive sign project in Florida was approved.

Coordinator Activities (Leah Elwell)

- Attended Theodore Roosevelt Conservation Partnership Policy Council annual meeting in DC
- Had individual meetings with the legislative staff of Baucus (MT), Feinstein (CA), Crapo (ID), Wolf (VA) and Rehberg (MT) in DC
- Met with J. Starinchek (Stop Aquatic Hitchhikers Campaign_ outreach coordinator in DC
- Participated in numerous conference calls as part of the Theodore Roosevelt Conservation Partnership Fish, Wildlife and Energy working group
- Participated in conference calls as part of the Endangered Species Coalition

Program Updates

- Invasive Species Program. Produced the Ultimate Didymo Resource Disc. This disc contains a biological paper written by Leah Elwell and EPA Sarah Spaulding, video documentary and other invasive species resources. The discs are available through FFF's main office.
- Invasive Species Program. Launched Clean Angling and Boating Pledge nationwide. Please show your support, commit to cleaning your gear and boat after each outing, and take the clean angling pledge to help prevent the spread of unwanted invasive species www.cleanangling.org
- The finishing touches are being put on the new Freshwater Catch and Release Brochure.
- Submitted 4 grant proposals to various foundations to support programs

Directions:
