## The President's Notes

Well, Spring is here and I hope you have been out fishing, or plan to soon. We have some great trips coming up, and I wanted to say a few things about safety on the stream.

Quite a few years ago when I joined the Club I wasn't that worried about safety on the stream or what could happen out there. Ask a few members who have been around for a while and they will tell you I took some chances that I am not proud about. So, here are a few of the things I have learned and most of you know:

- stay out of a flooded river – fish from shore if you have to fish  
(if you won't – wear a life jacket)
- use a walking stick if you have any doubt about your footing (I always do)
- test the depth of the water before getting in – clear water depth can be deceptive
- fish with a buddy or at least let someone know where you are and when you expect to be back  
(cell phones also offer a means to get help if needed)
- wear appropriate foot gear for the stream you plan to fish- its easy to fall
- wear a hat and glasses – sun and weather protection, and from hooks
- be very careful about getting your foot trapped – watch where you walk
- if you do fall in, float on your back and keep your feet pointed downstream and stroke to the side or where you can safely stand – don't panic!

## **What are Friends for?**

### **Spring Steelhead Trip to Pine Lake Trout Club March 26-29, 2009**

My fishing buddy, Ted Grossman and I arrived at Pine Lake around 11am on Thursday, and, after checking in, we headed for the Chagrin River. We stopped and fished at the Church on Route 174 and then proceeded down river to Rogers Road, then to Todd's Field, and did not see a single steelhead, although Ted was having fun landing small suckers. It was getting late and decided to make one more stop at the Chagrin River Park where we did see an occasional Steelhead, but none were biting. Decided to head back to Pine Lake (about 20 miles). Had dinner with several of the BUFF members in the dining room lounge at Pine Lake and then off to bed.

Next morning, Friday, the BUFF members met for a great breakfast at the Chester Dinner on Route 306. After breakfast, most of the BUFF members decided to go to the Grand River, but Ted and I decided to go back to the Chagrin River Park. When we arrived at 10am there was one other fisherman in sight landing a steelhead, and the steelhead were coming up the river in large numbers. The water was low, clear and very fast.

I had days earlier, talked to my son John in Pennsylvania who had just fished the Elk Creek, and all the fish he caught were in fast moving water in the rapids. He was using the woolly bugger and sucker spawn combination, and all were caught on the sucker spawn.

Ted proceeded down river about 100 yards from me and within minutes landed a steelhead in the fast moving rapids. Ted was having success in the rapids, and I found a slot of rapids and fast water next to the bank where steelhead were moving, and very quickly landed my first of many steelhead. Every single steelhead I caught, lost or broke off (all patterns I learned to tie) was on the trailer or point pattern (fluorescent orange sucker spawn, # 10 hook). I was using a (blue woolly bugger #10 hook) on the top or dropper pattern located about 18 inches from the trailer with a small shot above the dropper and a indicator float (white) about 4 feet above the patterns. Note: I ran out of fluorescent orange and went to fluorescent red, and had the same success.

There was an elderly gentleman fishing near me and I asked him to take my picture of me holding a steelhead I had just caught, which he graciously did. After which, we talked and I showed him the rig I was using, and I gave him some of the patterns I was using. About an hour later this same gentleman came up to me and said he had caught his first ever steelhead on the patterns I had given him.

It was around noon that I called Tom Herr on his cell phone and told him of our success and very shortly several of the BUFF group ascended on the River Park.

I did not move from my "honey hole" from 10am until 4pm except for a short intermission. I spotted Steve Walker in the water just upstream, and I called to Steve to come and fish my spot. I told Steve what patterns I was using, and he soon settled in and started to fish.

I headed toward the bank to have something to eat and was joined by Steve's buddy, Pete Moore. Within minutes Steve hooked onto a beautiful steelhead and began yelling for Pete to bring his net. Pete said, he was too tired, so I grabbed the net and headed across the river toward Steve. Got upriver of the steelhead, and netted Steve's steelhead. I took the steelhead out of the net and had Steve hold so I could get a picture. I got two very nice pictures of Steve and his steelhead.

**Pete arrived at the scene, but the action was over, and Steve was the proud owner of a great steelhead.**

**I guess to sum up my day other than catching a lot of steelhead: I loaned Steve my "honey hole", told him the patterns and rig I was using, netted his steelhead for him and took the pictures of proof of his catch. What else are friends for?**

## A reminder from Game Warden Jeff Tipton

### **Fellow Anglers,**

While working The Mad River today I was flagged down by a landowner who wanted to complain about an angler trespassing on his property. He pointed to the field along the river and said "if that guy walks another 100 yards, I want him arrested". I looked over and watched as a man carrying a flyrod and wearing breathable waders walked through the field to reach a fishing spot. I walked out and made contact with the guy and told him that I had a complaint from the landowner. He showed me his fishing license and told me that he was from Columbus and that he has belonged to a particular flyfishing club for about 4 years. I attempted to explain the issue and told him that his actions could cause the landowner to shut down the entire stretch of the river. I took his information and went to discuss the situation with the landowner. Thankfully, the landowner had calmed down a little and said that he only wanted the guy warned. The man pleaded ignorance about walking in the farm field, so hopefully I was able to educate him. Being that he's somewhat new to fishing The Mad, he likely did not know about the concerns of many landowners. Hopefully he will heed the warning. I left him, went south, and saw another flyangler walking through a field. He had a sticker on his truck from another fly club. Thankfully the landowner hadn't seen him.

I am certain that I am preaching to the choir on this issue, but I am asking for your help. Help me educate folks about the "rules of the river". It's especially important to educate folks that are new to the sport. All it takes is one unhappy landowner to shut down an entire section of river. If you all could spread the word to all the flyfishing clubs, I would appreciate it. Ask that they post this and other rules on their websites.

# **Fly Fishers Rescue Northern Kentucky Smallmouth Stream**

It has been five years since Northern Kentucky Fly Fishers entered the battle to rescue Gunpowder Creek from the ravages of deicing fluid discharged by the Cincinnati/Northern Kentucky International Airport. I am happy to report that Gunpowder Creek, once completely void of aquatic life, is now back to being one of our favorite smallmouth streams.

Deicing fluid is basically anti-freeze. A combination of propylene and ethylene glycol, it is essential to ensure the safe take-off of aircraft in the winter months. But this solution is also highly toxic to both humans and aquatic life and rather than disposing it in a safe manner, the Airport was simply dumping the spent deicing fluid into Gunpowder Creek. The creek, whose headwaters originate on Airport property, first flows through heavily populated areas of northern Boone County and then makes its way through the agricultural areas of southern Boone County where it then enters the Ohio River.

For years residents complained of a ghastly odor and discolored water, but the Kentucky Division of Water, who has the responsibility to regulate such discharges, was unresponsive. Independent water testing by volunteers including many members of Northern Kentucky Fly Fishers documented the presence of the highly toxic chemicals in the water and attempted sampling for macroinvertebrates demonstrated that Gunpowder Creek was void of all aquatic life.

Finally, in the summer of 2004, the Kentucky Division of Water (KDOW) issued a draft permit for public review. The limits and monitoring requirements in the draft permit were so weak they may as well have been non-existent. By most accounts it was as bad as having no permit at all.

Northern Kentucky Fly Fishers drafted a letter to the KDOW making recommendations for improvement of the draft permit. At its September 2004 monthly dinner meeting, 85 club members signed the letter to the KDOW. On September 9, 2004, the NKFF letter and signatures were presented to the KDOW at a public hearing held in Burlington. Thirty other local individuals and organizations also presented testimony at the hearing.

Almost 5 months to the day following the public hearing, the final permit was issued (February 7, 2005) and it represented a significant and precedent setting improvement over the draft. The permit required the airport to continuously monitor dissolved oxygen, pH and flow. The requirement for continuous monitoring means that the Airport had to install electronic probes in Gunpowder Creeks and monitor every minute of every day. This continuous monitoring requirement is a first of its kind in any permit issued by the KDOW and is one of the recommendations that were made by NKFF.

According to the Commissioner of the Division of Water, the strict permit was issued because of the level of public involvement and the volunteer work done by Northern Kentucky Fly Fishers was mentioned specifically.

The Airport now captures and recycles deicing fluid and the continuous monitoring ensures that the system works. Volunteers from Northern Kentucky Fly Fishers continue to monitor Gunpowder Creek and data from these volunteers has now been used to apply for an EPA 319 Grant that will provide over one million dollars to fully restore the stream. But even now, Gunpowder Creek has returned to life. Monitoring indicates that the water quality is good and smallmouth bass have returned to the stream and we are catching some 15 inchers these days.

Fly fishers know our waters better than most and can be a powerful force in protecting and restoring this precious resource. The story of Gunpowder Creek clearly demonstrates the power of the fly fishing community and what our on the ground work can do to protect our fisheries for future generations.

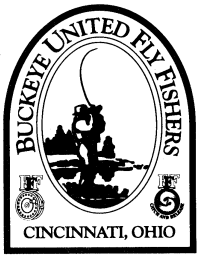

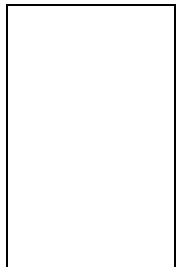

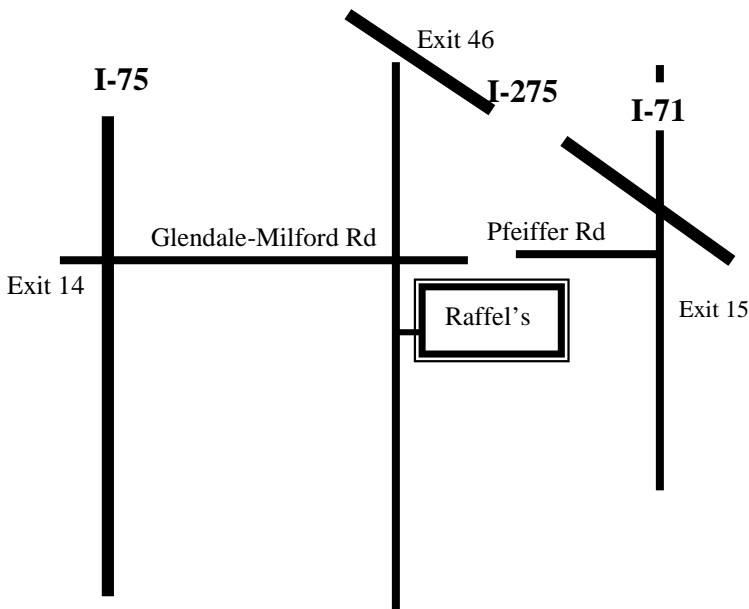

**From I-275 – Take Exit 46, (US 42), south for three miles to Glendale-Milford Rd. -- Continue south and RAFFEL'S will be on the left approximately 3/10 mile.**

**From I-75 -- Take Exit 14, east, on Glendale-Milford Rd. until the intersection of US 42, (Reading Rd). Turn right (south) on US 42, and RAFFEL'S will be on the left approximately 3/10 mile.**

**From I-71 -- Take Exit 15, west, Pfeiffer Rd. & this becomes Glendale-Milford Rd.. At the intersection of US 42, (Reading Rd), turn left, (south) on US 42, and RAFFEL'S will be on the left approximately 3/10 mile.**
